Tuition Reductions

A. 20% tuition reduction applied for families who also pay tuition for a child in a recognized Christian elementary school. Many of our partner Christian elementary schools also give a discount for having an older sibling at Woodland.

B. For most families, a donation receipt is available for a portion of the tuition fees paid. Woodland is a registered charity with the CRA. Any amount beyond the "cost per pupil" or academic cost is deemed a donation and a donation receipt will be issued annually.

C. Families for whom the tuition cost is still prohibitive are encouraged to apply to our Tuition Assistance Fund. If you wish to have more information about this Fund or would like to apply, please contact business@woodland.on.ca.

Sample Calculation

Formula to calculate reduction = $(\text{Tuition} - (\text{Cost per pupil} \times \# \text{ of students})) \times 40\%$

Example A - Base Rate (1 Child) with Christian Elementary Discount

After tax cost = \$17,260 - $(\$17,260 - (\$9,000 \times 1)) \times 40\%$ \$13,960

Example B - Base Rate (1 Child)

After tax cost = \$21,570 - $(\$21,570 - (\$9,000 \times 1)) \times 40\%$ \$16,540

Assumptions:

Cost per pupil (calculated annually based on CRA guidelines) \$9,000

Total non refundable tax credit (Federal + Provincial) for charitable donation 40%

Tuition Payment Policy

Tuition information is sent to all families in June. Tuition fees are to be paid in advance, either in full, or by monthly/semi-monthly installments via pre-authorized debit from your bank account.

Tuition Inclusions:

- A. Bus transportation.
- B. Textbooks are loaned to students. Students/parents are liable for lost or damaged books.
- C. All course related school trips.
- D. Student activity fees and yearbook.

Involved Parent Network (IPN)

Tuition includes an income component from our volunteer program. Volunteering at Woodland has a number of benefits, with one of them being fundraising which helps to reduce everyone's tuition. We do expect and encourage all Woodland families to be involved in our IPN. For those who are not able or willing to volunteer their time, you can instead make a voluntary \$800 donation to our Tuition Assistance Fund. The current year tuition reduction is \$800 per family and is already reflected in the tuition rates listed above.

We acknowledge that the financial cost of Christian education is high which may cause a considerable financial sacrifice for many of our families. At the same time, we believe that the Christian education we offer is well worth the price. In a very real way, tuition at Woodland is an investment in the future of our children, of our Christian communities, and of the world in which God has called us to serve.
